Sub: Commission Order on the application submitted online by the Higher Educational Institution (HEI) for recognition of the programmes to be offered in Online mode from 2021-22, academic session beginning November, 2021 (revised from July, 2021) onwards-regarding.

Sir/Madam,

In exercise of the powers conferred by sub-sections (1) and (2) of section 26 read with clause (j) of section 12 of the University Grants Commission Act, 1956 (3 of 1956), the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 was notified in the Gazette of India on 4th September, 2020 and amendment to these Regulations was notified in the Gazette of India on 1st July, 2021.

- 2. The eligibility criterion for Higher Educational Institution is enumerated under Regulation 3 in Part II of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendment(s). The Regulation 4 and 5 describe the process of application and the approval process for the Open and Distance Learning and Online Programmes whereas Regulations 6 describe provisions of right to appeal by the Higher Educational Institutions aggrieved with the order of the Commission and Regulations 7 describe the process of withdrawal of Recognition.
- 3. In accordance with the above Regulations, the Commission had invited online applications from the eligible Higher Educational Institutions for offering Open and Distance Learning and Online Programmes from 2020-21, academic session beginning January, 2021 and onwards vide public notice F.No.1-1/2020 (DEB-I) dated 23rd September, 2020, mentioning therein that the online portal for submitting applications shall be open upto 15.10.2020. Further, the last date for submitting applications was extended upto 31.10.2020. The G.L.A University, Uttar Pradesh had submitted its application for recognition of the Online Programmes.

4. Application received from G.L.A University, Uttar Pradesh had been scrutinized and deficiency(s) or defect(s) in application were communicated to HEI as per the University Grants Commission (Open and Distance Learning Programmes and Online

Programmes) Regulations, 2020 to remove or rectify such deficiency(s) or defect(s) along with relevant documentary evidence.

- 5. As the HEI had proposed a learning platform other than SWAYAM, it was invited for an Interface Meeting with the duly constituted Technical Expert Committee (TEC) on 12.04.2021 in which learning platform of HEI was found not complied. Based on the compliance submitted by the HEI, it was invited for second Interface meeting with Technical Expert Committee on 30.07.2021 Based on the recommendations of the Technical Expert Committee and its approval by the Competent Authority, the learning platform of the HEI was approved and same was conveyed to the HEI through UGC DEB portal on 18.08.2021.
- 6. The G.L.A University, Uttar Pradesh was visited virtually by the Visiting Expert Committee (VEC) constituted by the Chairman, UGC on 27.10.2021 and the report of the Visiting Expert Committee was considered by the Expert (Review) Committee (ERC) held on 02.11.2021. Based on the recommendation of Expert Review Committee (ERC) and its approval by the Competent Authority, the HEI was invited by the VEC for a second meeting in the UGC DEB Office, 35, Feroze Shah Road, New Delhi-110001 on 16.11.2021 to ascertain the quality of e-Learning Material and other related issues. The report of Visiting Expert Committee (VEC) was considered by Expert (Review) Committee (ERC) held on 23.11.2021.
- 7. The Expert (Review) Committee based on the application submitted, clarification given for the deficiency(s) or defect(s) communicated earlier, the reports of Visiting Expert Committee along with documentary evidence enclosed with the reports and in terms of provisions of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendment; made recommendations which have been approved by the Competent Authority.
- 8. Based on Commission decision taken in its 550th meeting held on 18th February, 2021, recommendations of Expert Review Committee (ERC) and its approval by the Competent Authority, I am directed to issue this Order, thereby communicating the programme wise recognition for the programmes to be offered in Online mode from year 2021-22, academic session beginning November, 2021 (revised from July, 2021) by the G.L.A University, Uttar Pradesh; as detailed in point no. 9 below.
- 9. Programme wise recognition status

Note:-

- 1. The Visiting Expert Committee/Expert Review Committee recommendation sheets approved by Competent Authority has already been communicated to the Higher Educational Institution through UGC-DEB portal on 25.11.2021.
- 2. *HEI shall ensure the compliance of Programmes under the ambit of Regulatory Authorities which have been considered on the basis of communication /recommendations received from respective Regulatory Authority. The HEI shall abide by the conditions such as number of seats, valid academic year, period of recognition etc. mentioned in the relevant Regulatory Authority letter.
- 10. For the programmes recognized in S.No. 9 above, the Higher Educational Institution shall comply with all the provisions of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendment(s) while offering the programmes in Online mode. Some specific provisions for compliance have been mentioned in **Annexure-I**.
- 11. Provision stipulated under Sub-Regulation 7 of Regulations 5 of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 states that:

"No Higher Educational Institution shall offer any Open and Distance Learning Programme and/or Online Programme and admit learners thereto unless it has been granted recognition by the Commission and admission shall not be made in anticipation of the recognition".

12.In the event of any Higher Educational Institution found offering programmes in Open and Distance Learning mode and/or Online mode without recognition of the Commission or in violation to any of the provisions of these regulations and its amendment(s) and guidelines or orders made there under, the Commission may take actions as per Sub Regulation 3 of Regulations 7 in Part-II of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendment(s).

Some Specific Provisions for Compliance

- The Higher Educational Institution shall comply to all the terms and conditions mentioned in the Affidavit dated 14.10.2020 duly notarized and signed by Shri. Ashok Kumar Singh, Registrar and Dr. Jeevanandam J., Director, Centre for Online Education submitted to the Commission.
- 2. The Higher Educational Institution shall scrupulously abide by all the terms and conditions of faculty and staff requirements for offering Online programmes as mentioned in University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 and its amendment(s).
- 3. Higher Educational Institution shall conduct proctored examinations as per provision stipulated under 15(C) & Annexure II of UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 either using technology enabled online test with all the security arrangements ensuring transparency and credibility of the examinations or through the Proctored Examination and in conformity with any other norms for such examination, as may be laid down by the Commission.
- 4. Higher Educational Institution offering programme in Online mode shall prepare e-Learning Material as per **Annexure-VII** of UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020 taking into consideration of the following:
 - (i) At least 60 percent of e-Learning Material shall be developed by the in-house faculty of the HEI and
 - (ii) Remaining percent of the materials can be sourced from available eresources such as Open Educational Resources (OER), SWAYAM or other source duly approved by the statutory authorities of the Higher Educational Institution.
- 5. Higher Educational Institution shall adhere to the weightage for different components of assessments for Open and Distance Learning mode and Online mode as under:
 - (i) Continuous or formative assessment (in semester): Maximum 30 per cent.

(ii) Summative assessment (end semester examination or term end examination): Minimum 70 per cent.
